Title: **A CLAMP FOR HOUSING FLUID DISTRIBUTION EQUIPMENT**

Abstract The invention relates to a new clamp for clamping fluid distribution equipment. The clamp includes an elongate member, having a first stationary end support and a second movable end support and having a plurality of apertures therein, wherein the second movable end support also having at least one aperture therein, wherein the first stationary end support further has at least one receiving formation for receiving an end of a cylinder and wherein the second movable end support further has a receiving formation for receiving a refill cap, such that in use, the second end support is displaceable between an engaged and disengaged position and maintained in the engaged position with the use of a rod, said rod being inserted through aligned apertures of the second end support and the elongate member.
