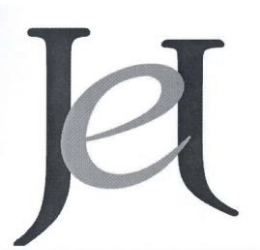

Any person who has grounds for objection to any Industrial Property matter published, may, within the prescribed time, lodge Notice of Opposition in the prescribed manner as stipulated in the Industrial Property Act, 2012 (Act No. 1 of 2012) and the regulations thereof. In terms of Regulation 10 (3), unless the Registrar otherwise directs, the bulletin must be published once every month.
