
Abstract: The present invention provides for modified Flavivirus such as a modified dengue virus type 1,2,3,4, a combination of these, or a tetravalent combination of these. The modification according to various aspects of the invention results in reduced viral protein expression compared to a parent virus, wherein the reduction in expression is the result of recoding one or more regions of the virus. 











